Position Title: Behavior Technician (BT/RBT)

Reports to: BCBA

Department: Clinical Team

Pay Type: Hourly

Summary

Provide one-on-one Applied Behavior Analysis (ABA) services to a child or young adult on the Autism Spectrum, under the guidance of a Board Certified Behavior Analysis (BCBA). Locations include but are not limited to: Center-based, community, and in-home settings. Typically, a part-time BT works up to 5 days per week, for approximately 10-20 hours per week. A full-time BT may work 30 or more hours per week.

Key Relationships

- Reports to the BCBA. This relationship is critical. A high level of trust between the Behavioral Technician and your supervisors is necessary for the successful functioning of the agency.
- Essential members of the Clinical Team. BTs are expected to work efficiently, independently, and safely while assuring that The Company's mission is a top priority.
- Strong, trusting and supportive relationships with the BCBA, Directors, and all other staff.

Essential Duties & Responsibilities

- Successfully follow and implement written behavior programming at the center, in-home, and/or in the community.
- Record behaviors in an accurate, detailed, and timely manner at the center, in-home, and/or in the community.
- Play an active, often physical role in activities with your client at the center, in-home, and/or in the community. This may require prolonged periods of standing and/or other physical activity.
- Confidently and independently manage behaviors that may occur at the center, in-home, and/or in the community.
- Collect/record daily data and session notes electronically via a tablet or similar device.
- Complete all assigned tasks accurately and in a timely manner as required.
- Provide client transportation in your own vehicle to and from the center, community, and/or client's home (as needed).
- Staff must maintain a valid driver's license, as well as carry an adequate vehicle
 insurance policy on the vehicle being used for transport (see Employee Handbook for
 requirements). Staff must maintain and submit a copy of a valid vehicle registration for
 the vehicle being used for transport, as well as submit a copy of the vehicle's
 safety/emissions inspection report, or photo of the inspection sticker, stating the vehicles
 successfully passed state requirements.
- Willingness to learn crisis de-escalation, passive restraint techniques.
- May be required to become Registered Behavior Technician (RBT) certified (currently optional).
- Willingness and ability to work as needed in various conditions.
- Attend staff training and meetings as required.
- Follow all supervision directives.
- Perform other duties/responsibilities as assigned.

Qualifications & Requirements

Education & Experience

- Degree in human services, education, or psychology preferred. If a preferred degree is not complete, experience working with individuals with disabilities may be required.
- Experience providing direct instruction and therapeutic services to children with Autism Spectrum Disorder preferred.

Language Skills

- Ability to read, analyze, and interpret documents.
- Ability to effectively communicate with all employees, groups of employees, and families.

Other Skills & Requirements

- Electronics literacy including; phones, laptops, and tablet devices. Or willingness to learn
- Ability to manage verbal and/or physical behaviors that may occur in a variety of settings.
- Current knowledge of, or ability to learn practice management and digital data collection software.
- Excellent organizational skills are essential.
- Effective people skills are essential.
- Possess a valid driver's license, have an excellent driving record and have access to a safe, reliable, insured vehicle.
- Ability to independently transport a child or young adult to and from a variety of settings (as needed).
- Ability to maintain confidentiality is critical.
